

SERVICES FOR PEOPLE WITH BRAIN INJURY IN VIRGINIA

The **Department for Aging and Rehabilitative Services (DARS)** is designated in the Code of Virginia as the lead state agency for planning and monitoring services that enhance the quality of life and work of Virginians with acquired brain injury.

DARS' **Brain Injury Services Coordination (BISC) Unit** oversees nearly \$6 million in funding for a statewide network of programs and services. BISC Unit also manages the BIDS Fund (*see below*) and provides staffing for the statewide Virginia Brain Injury Council (VBIC) and the Commonwealth Neurotrauma Initiative (CNI) Trust Fund. *Contact Chris Miller, Brain Injury Services Coordination Unit,* by phone 804/662-7069, e-mail *christiane.miller@dars.virginia.gov* or on-line http://www.vadars.org/cbs/biscis.htm.

Brain Injury Direct Services (BIDS) Fund provides short-term specialized services, assistive technology, and equipment and goods that assist Virginians with brain injury to live independently and move forward in their recovery. Funds are limited and can be used only if no other funding source is available ("fund of last resort"). BIDS Fund does *not* pay for inpatient medical rehabilitation or residential services. Individuals must be one year post-injury and meet disability and financial criteria. It is recommended to contact DARS prior to applying for funding.

State Contracted Programs and Services

The following organizations receive Commonwealth of Virginia state general funds to provide programs and services through contracts managed by the Department for Aging and Rehabilitative Services, Brain Injury Services Coordination Unit.

Brain Injury Association of Virginia (BIAV) provides information and support <u>statewide</u> to people with brain injury, family members/caregivers, and professionals. Brain Injury Connections of the Shenandoah Valley (<u>Greater Shenandoah</u> <u>Valley counties of Augusta, Bath, Highland, Page, Rockbridge, Rockingham and Shenandoah; cities of Buena Vista, Harrisonburg, Lexington, Staunton and</u>

<u>Waynesboro</u>) provides adult and pediatric case management, Community Support Services (life skills training), and Support Groups for individuals with brain injury. Brain Injury Services, Inc. (Northern Virginia, Winchester and Fredericksburg) provides adult and pediatric case management and operates a clubhouse program in Alexandria (ADAPT). Clubhouse members are actively involved in daily operations of the clubhouse through a work-ordered day which leads to improved work skills and behaviors that support community and vocational re-entry. BIS also operates a part-time day program as well as community outreach/engagement activities in Fredericksburg. Additional services include: supported living, assistive technology, and vocational services for adults with brain injuries. Clubhouses offer an array of services including limited case management services, volunteer placement services; in addition, clubhouses may offer vocational services such as Supported Employment Services (SES) and Employee Development Services (EDS).
